WELCOME

This collegiate chapter awards guide includes everything you need to know about Collegiate Chapter awards and is your guide to the awards process. We look forward to learning about your accomplishments and recognizing outstanding collegiate chapter achievements!

SUBMISSION REQUIREMENTS

- Chapters are encouraged to submit applications for all award categories.
- Each chapter may submit only one application per category award.
- Video submissions are required unless otherwise noted.

VIDEO SUBMISSION INFORMATION

- Videos may NOT be sourced out to professionals and must be recorded through Zoom or a similar platform.
- Videos should be a minimum of 2 minutes and not exceed 7 minutes. The content should cover the requested question prompts listed in this guide and on SmarterSelect.
- Officers featured in videos may screen share and/or use a slide presentation. If you do so, you are encouraged to utilize the AOII brand.
- Be sure to test your links prior to submitting your application.
- Be sure to grant access to ‘anyone with link’ when sharing your video link. If judges cannot access your video because of password protection, it will be disqualified.

SHARING YOUR VIDEO LINK

- **FOR ZOOM:** Please ensure that the recording is set to be shared publicly, that there is no expiration date, and that the password protection is turned off.
- **FOR GOOGLE:** Please upload the video file to your Google Drive and use the “Get Link” feature, ensuring that anyone can view the link.
- **FOR DROPBOX:** Please upload the video file to Dropbox and use the “Copy Link” share feature.

ELIGIBILITY

All chapters are eligible for recognition if the following criteria have been met:

- The chapter has remained in good standing with Alpha Omicron Pi throughout the 2025 calendar year.
- The chapter has remained in good standing with its college/university throughout the 2025 calendar year.
- The chapter may not be 30 days or more past due on any fees owed to the Fraternity or chapter's corporation.

DEADLINE

This awards submissions deadline is March 1, 2026 at 11:59 PM CDT.

AWARDS TIMELINE

Mid November 2025 – Award Applications Open

- Applications Lauch in SmarterSelect
- Award links, guides & instructions shared via email and the AOII website

Recommended Tasks

- Confirm Access – contact your previous officer to obtain your chapter's SmarterSelect login credentials.
- Log in immediately to ensure access, do not wait until February.
- Review All Applications
- Read through each award description & requirements carefully.
- Note which awards require video submissions or collaboration with other officers/ teams.
- Create a list of needed materials: photos, data, testimonials, video clips, & supporting documents.
- Schedule time with your leadership team to plan content capture.

December 2025 – Content Planning & Early Collection

Recommended Tasks

- Outline the story or message the chapter wants to share for each award category.
- Assign filming responsibilities.
- Begin collecting footage of key events or programs during the fall months.
- Meet with officers to gather input & media.
- Login to SmarterSelect to bookmark submission pages for quick reference.

January 2026 – Creation & Drafting Phase

AWARDS TIMELINE (CONTINUED)

Recommended Tasks

- Write responses/scripts in a shared document for collaboration & proofreading.
- Ensure examples and impact statements are detailed and data-supported.
- Capture interviews, event highlights, & member reflections.
- Begin editing early to avoid last-minute rushes.
- Have another officer review draft applications and video outlines for clarity & completeness.

February 2026 – Final Review & Upload Phase

Recommended Tasks

- Upload any written response, supporting materials, and video links to SmarterSelect.
- Confirm that video permissions are correct & accessible.
- Have AT LEAST two additional reviewers test each submission for accessibility & content accuracy.
- Double-check spelling, grammar, & formatting.
- Set an internal deadline for February 22nd to allow for a full week for final checks.

March 1, 2026 – Final Deadline

All Submissions Due by 11:59 CDT

- Ensure each award submission shows a “Submitted” status in SmarterSelect.
- Celebrate your team’s hard work in completing submissions and representing your chapter with pride!

Post-Submission Recommendations

- Reflect on the process & share what worked or what could improve.
- Save video submission materials for future use or reference.

GETTING STARTED

The Awards Committee is looking for applications that are creative, innovative and comprehensive. Award applications should be complete, answering each question in its entirety and honestly to the best of your chapter's ability. While it is suggested that Chapter Advisors and other members of the CCAB review the applications prior to submission, chapter officers are responsible for the creation and submission of each award application.

The chapter should have one officer designated to create a SmarterSelect Account and upload award submissions on behalf of the chapter. For Medium and Large chapters, this could be the Awards Coordinator, or VPO, in Small and X-Small chapters, this could be the VPO or CP. Each VP should oversee the creation of the awards submission videos in collaboration with her team, using the questions and guidelines in this Awards Guide. Once video content is created, the officer designated to submit the awards should collect video links and submit the awards on behalf of the chapter.

CREATING AND UTILIZING YOUR SMARTERSELECT ACCOUNT

Every chapter must set up one SmarterSelect account to use for the chapter awards process. Each chapter must create only one account for the submission of your chapter's award applications.

SMARTERSELECT USERNAME/EMAIL ADDRESS

Chapters should use an email address that is associated with an officer role. For instance, the Beta Alpha Chapter Vice President of Operations (VPO) might have an account email that is betaalphavpo@gmail.com.

If your chapter previously created an account with an awards email, you could continue to use the same account for chapter awards.

FIRST AND LAST NAME FIELDS

You should use your chapter name for the First Name and Last Name fields of the account. If you are a double-letter chapter, please use your first letter as your First Name and use your second letter as your Last Name. If you are a single-letter chapter, please use your single letter for your First Name and "Chapter" for your Last Name.

Beta Alpha Chapter will look like this:

First Name: Beta
Last Name: Alpha

Alpha Chapter will look like this:

First Name: Alpha
Last Name: Chapter

PASSWORD

When you create your password, make sure to use something that any Executive Team members can have access to and can remember so that everyone can work on their designated applications.

TRANSITION

Save the account information so that it can be passed along to the next Executive Team, and the information will not have to be altered or re-created.

ACCESS

Whomever has access to the account information may change any and all information at any point prior to submission. Therefore, it is imperative that all members with access to the account understand the responsibility of having access.

SAVE, RESUME & SUBMIT

All award applications can be saved and resumed at any point prior to the submission deadline. Be sure to hit SAVE when exiting the application and not SUBMIT. Applications cannot be retrieved and/or altered after they are submitted. **Submitting the application is FINAL.**

It is suggested that the Chapter President and the Executive Team review all applications prior to submitting them. Once the officers confirm the validity and honesty of the application, the Chapter President should consider reviewing the submission one final time for accuracy before submitting the completed application.

UTILIZING THE EXECUTIVE TEAM

It is in the chapter's best interest that the awards process is a collective effort of the Executive Team. Each application might need information from different Vice Presidents and their respective teams, so make sure that each officer knows what she is responsible for in terms of documenting appropriate information.

In the following pages, you will find the criteria and requirements for each award as well as the exact questions that will be asked in the award application. It is recommended that each officer be given the sections corresponding to her role and responsibilities and be directed to this awards packet on the Alpha Omicron Pi website.

COLLEGIATE AWARDS APPLICATION QUESTIONS

Inspiring Ambition in Community Relations Award

AWARD CRITERIA

The Inspiring Ambition in Community Relations Award is presented to the chapter or chapters that have supported AOII's mission and vision by setting strategy and overseeing the functional areas of communications, philanthropy, community engagement, campus and Panhellenic relations, and social events.

Recipients of this award have implemented intentional strategic planning, collaboration, and the development and maintenance of positive relations with external entities across campus and the community.

- The chapter has remained in good standing with Alpha Omicron Pi throughout the calendar year.
- The chapter has remained in good standing with its college/university throughout the calendar year.
- The chapter may not be 30 days or more past due on any fees owed to the Fraternity or chapter's corporation.

SUGGESTED OFFICERS

- VP of Community Relations
- Director of Philanthropy
- Director of Panhellenic Relations
- Director of Event Planning

AWARD QUESTIONS

1. Please provide your website address, and your social media account handles that you utilize to communicate with members, alumnae, and potential members.
2. How does your chapter inspire ambition in community relations by promoting yourselves, members, and events of the chapter?
 - a. Briefly highlight how your chapter incorporated new ideas into your social media plan this year.
 - b. Briefly highlight how your chapter promoted any event that was planned during the calendar year, either in-person or virtually.

3. Describe your chapter's philanthropic and service efforts related to arthritis support and/or the Arthritis Foundation. Include fundraising events and dollars raised, education and service as applicable.
4. Describe your chapter's philanthropic and service efforts related to your chapter's local philanthropy (other than the Arthritis Foundation). Include fundraising events and/or service opportunities.
5. Briefly highlight projects/activities/events (in-person or virtual) that your chapter sponsored and/or supported this year for your COLLEGE CAMPUS.
6. Briefly highlight projects/activities/events (in-person or virtual) that your chapter sponsored and/or supported this year for your COMMUNITY (outside of your campus).
7. Describe what efforts your chapter has made to enhance fraternity/sorority relations on your campus, i.e., partnering/co-sponsoring an event (not Strike Out Arthritis) or educational program with another fraternity/sorority.
8. Describe how the Community Relations team utilizes collaboration to achieve success.

Inspiring Ambition in Membership Experience Award

AWARD CRITERIA

The Inspiring Ambition in Membership Experience Award is presented to the chapter or chapters that have fostered an exceptional lifetime membership experience beginning as a new member, through the collegiate experience, and finally through the transition to alumnae status.

This award is earned by chapters who have displayed effective communication, created engaging programming, implemented innovative initiatives for developing sisterhood, and have consistently collaborated with Executive and Membership Experience Teams.

AWARD QUESTIONS

The Inspiring Ambition in Membership Integrity Award is presented to the chapter or chapters that have developed and maintained strong relationships with your chapter and in the world around us, while ensuring the favorable reputation and internal harmony of the chapter.

These chapters have worked to educate members about personal responsibilities and behavioral expectations set by AOII Governing Documents and local Chapter Bylaws through modeling exemplary behavior, effective communication, and education.

3. Describe how your chapter communicates and manages officer budgets.
4. Describe the chapter's year-round education plan in the areas of risk reduction and prevention.

Inspiring Ambition in Membership Recruitment Award

AWARD CRITERIA

The Inspiring Ambition in Membership Recruitment Award is presented to the chapter or chapters that have performed exceptionally in promoting the sorority experience to potential new members and welcoming new members into Alpha Omicron Pi.

Recipients of this award consistently excel in all chapter operations related to membership recruitment including primary recruitment, continuous open bidding (COB), bid day, recruitment practice, membership selection functions, and promotional activities.

The Inspiring Ambition in Programming & Enrichment Award is presented to the chapter or chapters that have successfully implemented a holistic approach to all facets of membership enrichment through intentional programming to build resilience, confidence and ambition.

Recipients of this award organically foster a culture of diversity, equity and inclusion through ongoing education and enrichment in the areas of personal development, personal well-being and AOII principles and values. The chapters excel in their efforts to effectively communicate, create ongoing intellectual curiosity, establish innovative initiatives, engage facilitation, and collaborate with our Executive and Programming and Enrichment Teams.

5. Describe how the Programming & Enrichment team has utilized the strategy to create a comprehensive member educational program. This may include how Ritual Education, DEI, academics, and health and wellbeing have been married together, how programs and chapter needs are assessed, how programming is designed to support chapter initiatives, etc.
